Licensing Authority

Our Role: - to be responsible for licensing the sale of alcohol, regulated entertainment (such as music, dancing and boxing) under the Licensing Act 2003.

All powers under the Licensing Act 2003 relate to the promotion and sub-paragraph of the 4 licensing objectives:

- ✓ the prevention of crime and disorder
- ✓ public safety
- ✓ the prevention of nuisance
- ✓ the protection of children from harm

Conditions are placed on licences to safeguard these 4 licensing objectives and the Licensing Act 2003 allows the Licensing Authority to prosecute or revoke premises licences where the licensee fails to uphold the objectives.

Reviews
10 Licensed premises took place last year because operators failed to comply with the law. 4 premises licences were suspended and 2 of the premises owners were convicted. Reviews are required by responsible authorities such as the police and environmental health or to other related parties such as someone who lives or is located in the vicinity of the licensed premises or a neighbour.
